

## Motoring offences – our prices and services

Cases of this type can vary enormously in terms of the amount of documentation involved, the number of witnesses, the complexity of any legal issues and the number and length of any hearings. For this reason, predicting the likely total cost of representation is difficult. We have therefore provided a range of costs below and outlined some of the factors which are likely to influence where in the bracket your case will fall. ### Third party costs (referred to as disbursements)

We may need to involve other experts in your case, for example, medical experts or barristers and will inform you of these costs on a case by case basis.

## Timescales

Matters usually take between 1 to 3 months in the Magistrates Court, depending on the type of matter and whether the matter proceeds by way of guilty or not guilty plea. Matters sent to the Crown Court can take considerably longer (12 months or more). We will advise you on the anticipated length of the matter once we have considered your instructions.
